Appointment Process

In order to become an appointed broker with Arch Insurance's Accident and Health unit, we will need the following information from you:

W9Copy of your E&O Policy

A completed ACH form

Licensing Information

Upon receipt of all of the required documents, we will get to work! It may take 1-2 weeks to process, and you'll receive an email from your account manager when all is complete. You'll also receive another email with log-in information to any online portals you may use.

In order to sell a travel insurance policy, including an Annual Multi-Trip* plan, you will need the following licenses based on the states in which you plan to sell the policy.
